 - 2. Section 2. of the Agreement is hereby amended to read as follows.
- "2. TERM. The term of this Agreement shall commence at midnight on December 1, 2020, and shall terminate at 11:59 p.m. on November 30, 2023, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of the City Manager."
