AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE USE DISTRICT MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS BEEN ESTABLISHED AND AMENDED BY AMENDING PORTIONS OF PART 15 OF SAID MAP FROM COMMERCIAL STORAGE (CS), COMMERCIAL STORAGE WITH HORSE OVERLAY (CS (H)) AND SINGLE-FAMILY RESIDENTIAL, STANDARD LOT (R-1-N) TO RESIDENTIAL, PLANNED UNIT DEVELOPMENT, 15 DU/AC (RP-15) AND RESIDENTIAL, PLANNED UNIT DEVELOPMENT, 15 DU/AC WITH HORSE OVERLAY (RP-15 (H))

The City Council of the City of Long Beach ordains as follows:

17 Section 1. Environmental documentation prepared, having been 18 received, considered, approved, and certified as required by law, and the City Council 19 hereby finding that the proposed change will not adversely affect the character, livability 20 or appropriate development of the surrounding area and that the proposed change is 21 consistent with the goals, objectives and provisions of the General Plan, the official Use 22 District Map of the City of Long Beach, as established and amended, is further amended 23 by amending portions of Part 15 of said Map from Commercial Storage (CS), Commercial 24 Storage with Horse Overlay (CS (H)) and Single-Family Residential, Standard Lot (R-1-N) 25 to Residential Planned Unit Development, 15 du/ac (RP-15) and Residential, Planned Unit 26 Development, 15 du/ac with Horse Overlay (RP-15 (H)).

27 Section 2. Those portions of Part 15 of said Map that are amended by 28 this ordinance are depicted on Exhibit "A" which is attached hereto and by this reference

Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.


