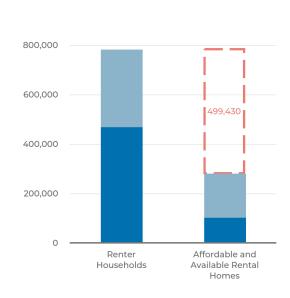
Context of Housing Instability in California

499,430 low-income renter households in Los Angeles County do not have access to an affordable home (2019).

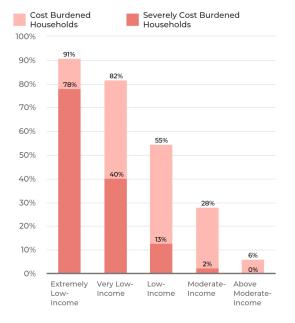

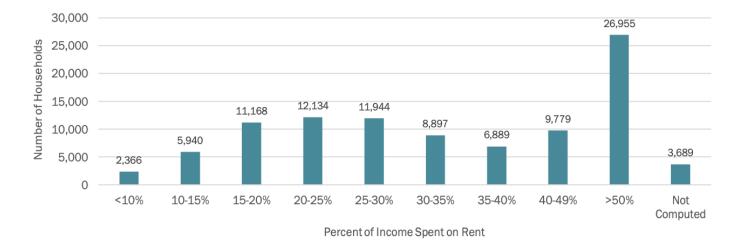
78% of ELI households in Los Angeles County are paying more than half of their income on housing costs compared to just 2% of moderate-income households (2019).

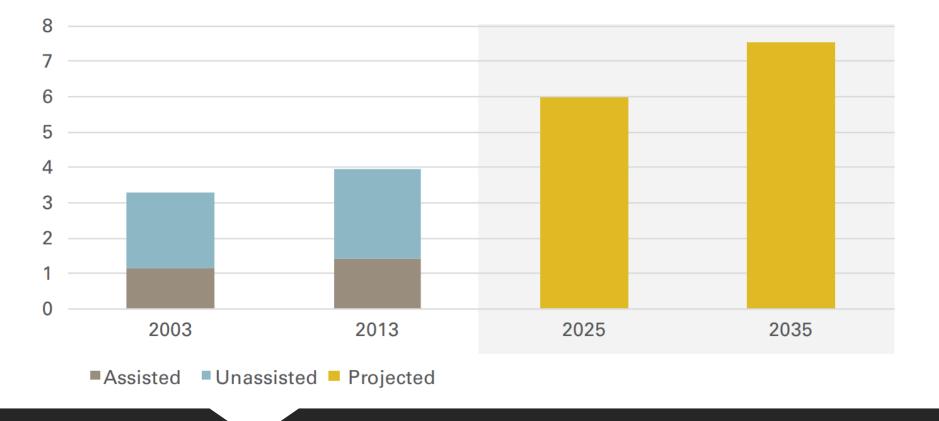
Spending on Rent



Across Long Beach's 99,761 renter households, 52,520 (52.6%) spend thirty percent or more of gross income on housing cost, compared to 55.3% in the SCAG region. Additionally, 26,955 renter households in Long Beach (27%) spend fifty percent or more of gross income on housing cost, compared to 28.9% in the SCAG region.

Housing Burden in Long Beach; 52.6% of residents spend 30% or more of gross income on housing costs.

Very Low-Income Renter Households Aged 62 and over (Millions)



Notes: Households eligible for assistance have very low incomes (at or below 50 percent of area median). HUD assisted and unassisted households represent renters with very or extremely low incomes aged 62 and over. To approximate the number of very low-income households aged 62 and over in 2025 and 2035, JCHS estimates take the average of the projected number of very and extremely low-income renter households are 65 and over

Low-Income Older Renters Eligible for Housing Assistance in Long Beach; <u>Projected to double by 2035</u>

Few older households who rent in Long Beach can afford long-term care costs.

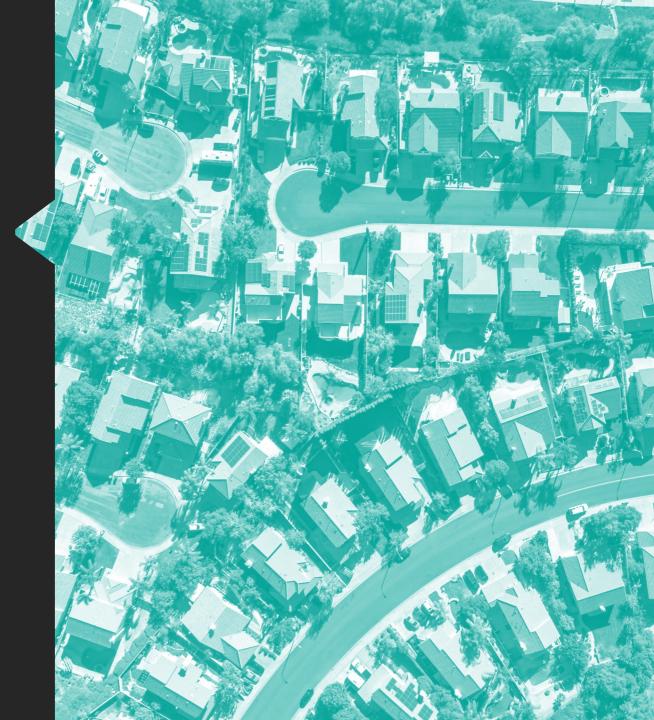

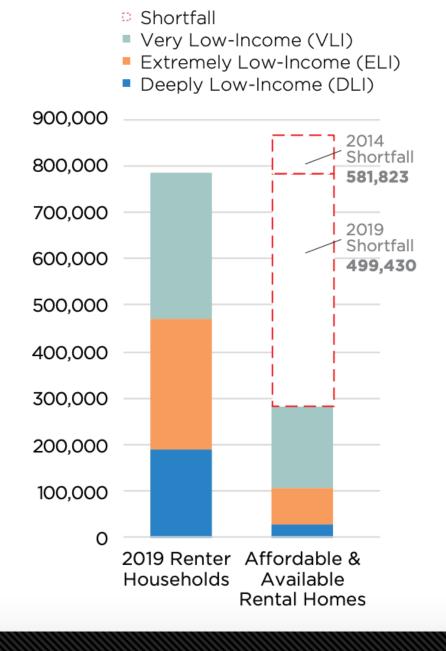
HUD Buildings in LB

Why do we need Senior-Focused Housing Policy?

Production & Preservation of HUD Housing for Older Adults
One in three seniors pay 50% or more/month to housing
Fixed monthly income: Social Security/pension
Higher health costs and needs
More incentive for owners to keep units HUD subsidized
