

FIFTH AMENDMENT TO AGREEMENT NO. 34871

THIS FIFTH AMENDMENT TO AGREEMENT NO. 34871 is made and entered, in duplicate, as of January 3, 2023 for reference purposes only, pursuant to Resolution No. RES-17-0146 adopted by the City Council of the City of Long Beach at its meeting on December 12, 2017, by and between PRUDENTIAL OVERALL SUPPLY, a California corporation ("Contractor"), whose address is 1661 Alton Parkway, Irvine, California 92606, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34871 (the "Agreement") whereby Contractor agreed to provide uniform rental services, floor mats, mops and related services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to January 31, 2020 and add the authorized annual amount; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to January 31, 2021 and add the authorized annual amount; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to January 31, 2022 and add the authorized annual amount; and

WHEREAS, the Parties entered into a Fourth Amendment to extend the term one (1) additional one-year period and add the authorized annual amount of \$446,000;

WHEREAS, the Parties currently desire to extend the term to October 31, 2025;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.D. of Agreement No. 34871 is hereby amended to read as follows:

"D. The term of this Agreement shall commence at midnight on February 1, 2018, and shall terminate at 11:59 p.m. on October 31, 2025, with the option to renew as long as the Omnia Partners Contract No. 171695 is in effect, at
