## AMENDMENT No. 1 TO FUNDING AGREEMENT BETWEEN CITY OF LONG BEACH AND THE LOS ANGELES COUNTY METROPOLITAN TRANSPORTATION AUTHORITY

This Amendment No. 1 to Funding Agreement (this "Amendment"), is dated as of October 21, 2022, by and between City of Long Beach ("GRANTEE"), and the Los Angeles County Metropolitan Transportation Authority ("LACMTA").

## **RECITALS:**

- A. GRANTEE and LACMTA entered into that certain Funding Agreement No. 920000000F9628, dated October 19, 2021, (the "Existing FA"), which Existing FA provides for the 1st Street Pedestrian Gallery (the "Project"); and
- B. Whereas, LACMTA Board on August 25, 2022, desires to extend the lapsing date of the Project to February 29, 2024.
- C. GRANTEE and LACMTA desire to amend the Existing FA as provided herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as follows:

- 1. Part II, Paragraph 8.1 (iv) of the Existing FA is hereby amended by deleting it in its entirety and replacing it with the following:
- "8.1 (iv) Expending the Funds granted under this FA for allowable costs by the lapsing date. All Funds programmed for FY 2018-19 and FY 2019-20 are subject to lapse on February 29, 2024."
- 2. Attachment B Scope of Work, attached to the Existing FA is hereby amended by deleting the Schedule / Milestones and replacing it with the following Revised Project Schedule.
