


3	AN ORDINANCE OF THE CITY COUNCIL OF THE
4	CITY OF LONG BEACH AMENDING THE USE DISTRICT
5	MAP OF THE CITY OF LONG BEACH AS SAID MAP HAS
6	BEEN ESTABLISHED AND AMENDED BY AMENDING
7	PORTIONS OF PART 22 OF SAID MAP FROM COMMUNITY
8	COMMERCIAL AUTOMOBILE-ORIENTED (CCA) AND
9	SINGLE-FAMILY RESIDENTIAL, LARGE LOT (R-1-L) TO
10	MIXED-USE ZONE-1 (MU-1)

12	The City Council of the City of Long Beach ordains as follows:
13	
14	Section 1. Environmental documentation having been prepared,
15	received, considered, approved, and certified as required by law, and the City Council
16	hereby finding that the proposed change will not adversely affect the character, livability
17	or appropriate development of the surrounding area and that the proposed change is
18	consistent with the goals, objectives and provisions of the General Plan, the official Use
19	District Map of the City of Long Beach, as established and amended, is further amended
20	by amending portions of Part 22 of said Map from Community Commercial Automobile-
21	Oriented (CCA) and Single-family Residential, large lot (R-1-L) to Mixed-Use Zone-1 (MU-
22	1).
23	Section 2. Those portions of Part 22 of said Map that are amended by
24	this ordinance are depicted on Exhibit "A" which is attached hereto and by this reference
25	made a part of this ordinance and the official Use District Map of the City.
26	Section 3. All ordinances and parts of ordinances in conflict herewith are
27	hereby repealed.
28	Section 4. The City Clerk shall certify to the passage of this ordinance by
