Executive Summary

Board of Utilities Commissioners approval is requested to enter into contracts with 33 engineering consultants to provide professional engineering services on an as-needed basis for the following Long Beach Utilities Department (LBUD) programs and special tasks: pipeline improvements, pipeline condition assessment, cathodic protection, hydraulic modeling, water resources planning, pump station improvements, tank rehabilitation, groundwater well, groundwater treatment plant improvements, miscellaneous engineering support services, and natural gas – regulatory compliance.

The demand for specialized on-call professional engineering services has significantly grown in the past few years due to the increase in LBUD's planned and budgeted capital improvement program (CIP) projects. These on-call contracts provide LBUD with the necessary specialty support services to address infrastructure improvements.

The on-call contracts will be based on authorization of work issued by LBUD and do not include a guaranteed minimum payment or retainer fee. Payment to the consultants will be based on authorization of work issued by the Department and completed by the consultants.

On February 7, 2023, 34 proposals were received and reviewed; 33 proposals were determined to be qualified and responsive in the programs and special tasks the consultants were being considered. Qualifications were based on the following criteria: demonstration of competence, experience in performance of comparable engagements, expertise and availability of key personnel, and reasonableness of fee. One proposal was determined to be incomplete, and therefore not responsive to the RFQ. All 33 complete proposals were selected to ensure adequate coverage across the various programs and special tasks.

The total aggregate contract authority will not exceed \$21,000,000 for a period of two years, with the option to renew for one-year year. The requested contract amount was calculated based on current, anticipated, and possible future projects within various groups within the LBUD.

Fiscal Impact: The contract amount is based on historical annual CIP engineering design and inspection services of \$11 million split between the Water, Sewer, and Gas Funds. Allocations for these services are currently budgeted in the FY 23 CIP and will be included in future financial projections.
