DISCUSSION

On June 15, 2022, Code Enforcement received a complaint at 5372 Orange Ave for discarded furniture, trash and debris.

On August 12, 2022, a site inspection revealed violations for sanitation, discarded furniture and trash cans visible from public view. A violation notice was sent to the owner.

On August 17, 2022, a reminder letter was mailed out.

On September 30, 2022, the first Administrative Citation was issued for sanitation, discarded furniture and trash cans visible from public view. Photos were taken.

On October 13, 2022, the owner contacted me stating he received the Administrative Citation Warning letter and the first Administrative Citation. He said he would try his best to keep the property clean to avoid any additional Citations.

On January 20, 2023, a second Administrative Citation was issued for sanitation, discarded furniture and trash cans visible from public view. Photos were taken.

This property was brought before the board on December 12, 2022 to appeal the first Administrative Citation dated. The appeal was denied.
