3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH, CALIFORNIA, DESIGNATING AND  
5 AUTHORIZING THE CITY MANAGER AND CITY  
6 PROSECUTOR TO EXECUTE APPLICATIONS,  
7 AGREEMENTS, AND OTHER NECESSARY DOCUMENTS  
8 TO ACCEPT AND EXPEND FUNDING FROM THE  
9 CALIFORNIA DEPARTMENT OF JUSTICE TOBACCO  
10 GRANT PROGRAM

12 WHEREAS, the California Department of Justice (“CDOJ”) Tobacco Grant  
13 Program (“Program”) was established in 2017 by the Office of the Attorney General to  
14 support local enforcement of tobacco laws; and

15 WHEREAS, the Program supports a wide range of activities, including  
16 consumer protection, retailer compliance checks, public education outreach, and  
17 inspection and enforcement efforts; and

18 WHEREAS, the City of Long Beach has been selected for this Program and  
19 desires to accept the Program’s funding; and

20 WHEREAS, the Program will support efforts led by the Long Beach City  
21 Prosecutor’s Office to increase prosecutions of repeat offenders for unlawful sale of  
22 tobacco products to minors, provide training for local prosecutors, and increase  
23 educational outreach to retailers with the goal of preventing tobacco sales to minors; and

24 WHEREAS, the Program will provide funding in an amount not to exceed  
25 Five Hundred Five Thousand One Hundred Forty-Six Dollars (\$505,146) throughout the  
26 Fiscal Years between 2022-2025;

27 NOW, THEREFORE, the City Council of the City of Long Beach resolves as

Section 1. That the foregoing recitals are true and correct and are incorporated herein by this reference.

Section 2. The Long Beach City Manager and/or the Long Beach City Prosecutor, or their designees, are hereby authorized to execute and submit on behalf of the City of Long Beach City Prosecutor's Office, the City of Long Beach, a local government established under the laws of the State of California, applications and other related documents, including agreements, amendments, extensions, and grant award documents, for the purpose of obtaining and expending grant funding from the California Department of Justice Tobacco Grant Program.

Section 3. This authorization shall be in effect for the duration of the Fiscal Years for 2022-2023, 2023-2024, and 2024-2025 Program periods.

Section 4. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
