RES-23-0032** 2 3 A RESOLUTION OF THE CITY COUNCIL OF THE 4 CITY OF LONG BEACH AUTHORIZING APPLICATION TO 5 PARTICIPATION THE AND IN PROHOUSING 6 **DESIGNATION PROGRAM** 7 8 WHEREAS, Government Code Section 65589.9 established the Prohousing 9 Designation Program ("PDP" or "Program"), which creates incentives for jurisdictions that 10 are compliant with state housing element requirements and that have enacted Prohousing 11 local policies; and 12 WHEREAS, such jurisdictions will be designated prohousing, and, as such, 13 will receive additional points or other preference during the scoring of their competitive 14 applications for specified housing and infrastructure funding; and 15 WHEREAS, the Department of Housing and Community Development 16 ("Department') has adopted emergency regulations (Cal. Code Regs., tit. 25, §6600 et 17 seq.) to implement the Program ("Program Regulations"), as authorized by Government 18 Code section 65589.9, subdivision (d); and 19 WHEREAS, the City of Long Beach ("Applicant") desires to submit an 20 application for a Prohousing Designation ("Application"); 21 NOW, THEREFORE, the City Council of the City of Long Beach resolves as 22 follows: 23 Applicant is hereby authorized and directed to submit an Section 1. 24 Application to the Department. 25 Section 2. Applicant acknowledges and confirms that it is currently in 26 compliance with applicable state housing law. 27 Section 3. Applicant acknowledges and confirms that it will continue to 28 comply with applicable housing laws and to refrain from enacting laws, developing policies, 1

production. Examples of such local laws, policies, and action include moratoriums on
development; local voter approval requirements related to housing production;
downzoning; and unduly restrictive or onerous zoning regulations, development standards
or permit procedures. Applicant further acknowledges and conforms that it commits itself
to affirmatively furthering fair housing pursuant to Government Code section 8899.50.


Section 4. If the Application is approved, Applicant is hereby authorized
and directed to enter into, execute, and deliver all documents required or deemed
necessary or appropriate to participate in the Program, and all amendment thereto (the
"Program Documents").

Section 5. Applicant acknowledges and agrees that it shall be subject to the Application, the terms and conditions specified in the Program Documents, the Program Regulations, and any and all other applicable law.

Section 6. The City Manager or designee is authorized to execute and
deliver the Application and the Program Documents on behalf of the Applicant for
participation in the Program.

Section 7. This resolution shall take effect immediately upon its adoption
by the City Council, and the City Clerk shall certify the vote adopting this resolution.
