3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE AN AGREEMENT WITH VOLVO
6 CONSTRUCTION EQUIPMENT NORTH AMERICA, LLC, OF
7 SHIPPENSBURG, PA, FOR THE PURCHASE OF TWO
8 VOLVO L120H WHEEL LOADER TRACTORS, WITH
9 RELATED EQUIPMENT AND ACCESSORIES, ON THE
10 SAME TERMS AND CONDITIONS AFFORDED TO
11 SOURCEWELL (FORMERLY THE NATIONAL JOINT
12 POWER ALLIANCE) IN A TOTAL AMOUNT NOT TO
13 EXCEED \$664,777

15 WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802,
16 permits the City to purchase services, supplies, materials, equipment and labor with other
17 government agencies by purchasing under their contracts on a voluntary and selective
18 basis when authorized by resolution; and

19 WHEREAS, the City desires to purchase two Volvo L120H Wheel Loader
20 tractors, with related equipment for use by the Department of Parks, Recreation and
21 Marine, Beach Maintenance Division, to provide critical support for the maintenance of the
22 City of Long Beach beaches, especially during storm season when large amounts of debris
23 and sand need to be removed; and

24 WHEREAS, City Council authorized replacing these units in the approved
25 FY21 replacement plan. The current units are four years past their useful life and are
26 becoming increasingly more expensive to maintain;

27 WHEREAS, Fleet Services Bureau researched procurement options for
28 heavy construction equipment and discovered other agencies had completed an open, fair,

1 transparent and competitive procurement process.

2 WHEREAS, the City determined that Sourcewell's contract with Crane
3 Carrier and Scranton Manufacturing through their local dealer, Velocity Truck Centers, who
4 will assemble the trucks to meet the City's needs and specifications provided the best value
5 to the City while allowing for timely acquisition and delivery; and

6 WHEREAS, Sourcewell entered into Sourcewell Contract Number 032119-
7 VCE with Volvo Construction Equipment North America, LLC for the purchase of two Volvo
8 L120H Wheel Loader tractors, with related equipment and accessories ("Sourcewell
9 Contract"); and

10 WHEREAS, the City's participation in the Sourcewell Contract will facilitate
11 the City's ability to purchase as well as provide considerable cost benefits to the City; and

12 WHEREAS, if the City had to utilize a formal bid process rather than
13 participate in the Sourcewell Contract, considerably more funds would be required;

14 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
15 follows:

16 Section 1. The above recitals are true and correct and are incorporated
17 herein by this reference.

18 Section 2. The City Manager or designee is hereby authorized to enter an
19 agreement with Volvo Construction Equipment North America, LLC, for the purchase of
20 two Volvo L120H Wheel Loader tractors with related equipment and accessories, of the
21 same type and kind identified in the Sourcewell Contract except as modified by mutual
22 agreement of the City and Volvo Construction Equipment North America, LLC, and the
23 purchase by the City shall be on the same terms and conditions afforded to the Sourcewell
24 in an amount not to exceed Six Hundred Sixty-Four Thousand Seven Hundred Seventy-
25 Seven Dollars (\$664,777) including taxes and fees.

Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.


