THIS THIRD AMENDMENT TO AGREEMENT NO. 35889 is made and entered, as of February 13, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 23, 2020, by and between JACOBS PROJECT MANAGEMENT CO., a Delaware corporation ("Consultant"), with a place of business at 2600 Michelson Drive, Suite 500, Irvine, California 92612, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35889 (the "Agreement") whereby Consultant agreed to provide as-needed engineering construction management services for various development projects at the Long Beach Airport; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$200,000 for a total not to exceed amount of \$2,200,000, and attach an updated rate sheet; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$317,228 for a total not to exceed amount of \$2,517,228; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions contained herein, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on March 1, 2021, and shall terminate at 11:59 p.m. on February 28, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of the City Manager."
