## ORDINANCE NO. ORD-23-0015

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY REPEALING SECTION 5.81.070(F), RELATING TO A PROHIBITION ON THE SALE OF FLAVORED TOBACCO PRODUCTS

WHEREAS, effective January 1, 2023, Senate Bill 793 (SB 973) imposed a statewide ban on the sale of most flavored tobacco products; and

WHEREAS, by its own terms, Long Beach Municipal Code section 5.81.070(F) become inoperative and was repealed on the effective date of SB 973's Statewide prohibition on the sale of flavored tobacco products; and

WHEREAS, as Long Beach Municipal Code Section 5.81.070(F) became inoperative and was repealed once SB 973's Statewide prohibition on the sale of flavored tobacco products took effect on January 1, 2023, this Ordinance formally repeals said section from the Municipal Code;

NOW, THEREFORE, the City Council of the City of Long Beach ordains as follows:

Section 1. Section 5.81.070(F) of the Long Beach Municipal Code is hereby repealed.

Section 2. The City Clerk shall certify to the passage of this ordinance by City Council and cause it to be posted in three (3) conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the Mayor.
