FIRST AMENDMENT TO AGREEMENT NO. 36260

36260

THIS FIRST AMENDMENT TO AGREEMENT NO. 36260 is made and entered, in duplicate, as of February 10, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on November 1, 2022, by and between LONG BEACH MEMORIAL MEDICAL CENTER, a California nonprofit corporation ("Contractor"), with a place of business at 2801 Atlantic Avenue, Long Beach, California 90806 and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with training and employment opportunities for economically disadvantaged, unemployed and underemployed persons consistent with the Workforce Innovation and Opportunity Act; and

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 36260 (the "Agreement") whereby Contractor agreed to provide these services; and

WHEREAS, the Parties desire to add One Hundred Thousand Dollars (\$100,000) for a total amount of Three Hundred Thousand Dollars (\$300,000), and extend the term of the contract by one (1) year;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2.A. of the Agreement is hereby amended to read as follows.
- "A. The term of this Contract ("Term") shall be deemed to have commenced as of January 1, 2022, and unless sooner terminated pursuant to the provisions hereof, shall terminate on December 31, 2023. Either of the parties hereto shall have the right to terminate this Contract in its entirety at any time during the Term for any or no reason whatsoever by giving fifteen (15) days prior written notice of termination to the other party. City shall have the additional right to cancel any part of this Contract at any time during the Term for any reason whatsoever by giving fifteen (15) days' notice of such

cancellation to the Contractor."

- 2. Section 5.A. of the Agreement is hereby amended to read as follows.
- "A. The total amount which shall be payable by City to the Contractor for Contractor's allowable services during the Term shall not exceed Three Hundred Thousand Dollars (\$300,000)."
- 3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 36260 are ratified and confirmed and shall remain in full force and effect.
