### SIXTH AMENDMENT TO AGREEMENT NO. 34908

THIS SIXTH AMENDMENT TO AGREEMENT NO. 34908 is made and entered, in duplicate, as of March 8, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on January 17, 2023, by and between STANTEC CONSULTING SERVICES INC., a New York corporation ("Consultant"), with a place of business at 370 Interlocken Boulevard, Suite 200, Broomfield, Colorado 80021, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34908 (the "Agreement") whereby Consultant agreed to provide on-call professional engineering and architectural services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$350,000 for a total not to exceed amount of \$3,350,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to add \$850,000 for a total not to exceed amount of \$4,200,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$1,987,319 for a total not to exceed amount of \$6,187,319; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to February 28, 2022; and

WHEREAS, the Parties entered into a Fifth to extend the term to February 28, 2023;

WHEREAS, on January 17, 2023, the City Council authorized extending the Agreement term for an additional three-year period, with the option to renew for two additional one-year periods, at the discretion of the City Manager; and

WHEREAS, the Parties desire to extend the term by an additional three (3) year period, with the option to renew for two additional one-year periods, at the discretion of the City Manager, add Two Million Four Hundred Ninety-Six Thousand Two Hundred

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A. of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Eight Million Six Hundred Eighty-Three Thousand Five Hundred Twenty-Four Dollars (\$8,683,524), at the rates or charges shown in Exhibit "B".
  - 2. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on March 1, 2018 and shall terminate at 11:59 p.m. on February 28, 2026, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of City Manager."
- 3. The rates in Exhibit "B" to the Agreement are hereby amended in accordance with Exhibit "B-1", attached hereto and incorporated by this reference.
- 4. The City's Representative in Exhibit "C" to the Agreement is hereby amended in accordance with Exhibit "C-1", attached hereto and incorporated by this reference.
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34908 are ratified and confirmed and shall remain in full force and effect.
