## Recommendation

Adopt Specifications WD-04-22 for the Spinnaker Bay Drive Water Main Replacement – Phase 2 (MC-5200) and authorize the General Manager to sign a construction contract with ARB, Inc., in the amount of \$3,010,871.

## **Executive Summary**

On March 7, 2023 and March 14, 2023, staff published the Notice of Inviting Bids for the Spinnaker Bay Drive Water Main Replacement Project – Phase 2 (MC-5200) as required by Public Contract Code Section 22037. The work involves furnishing all labor, equipment, and materials necessary to install over 2,400 linear feet of polyvinyl chloride pipe, including installation of valves and fittings, water service connections, fire hydrants, connections to existing water mains, surface restoration, and traffic control.

On April 12, 2023, three bids were received and opened. The bid tabulation is attached. The lowest responsive bid, submitted by ARB, Inc. in the amount of \$3,010,871, was found to be in conformance with the bid documents.

The Engineer's estimate is \$2,600,000.

## Fiscal Impact

The cost to the Water Fund will be incurred in FY 23 and FY24, with the total amount not to exceed the contract total of \$3,010,871. These costs are included in the Water Fund FY 23 CIP budget and financial projections for FY 24.
