Although SB 946 was designed for local jurisdictions to implement their own policies regarding street vendors that best suit their communities, these recommendations do not seem to keep LB's rich history in mind. On the contrary, they will further disenfranchise even more poor/working-class residents from participating in our local economy. The firm that created these recs, Lisa Wise Consulting, is based in San Luis Obispo, a predominately white community, and a majority of its staff are white/white-presenting- thus not centering the most impacted individuals, BIPOC communities. If the council accepts these recommendations, as is, it will further perpetuate systemic racism that will drastically change the landscape of some of our treasured community spaces such as our local parks/beaches.</p>	5/16/2023
