## FIRST AMENDMENT TO AGREEMENT NO. 36175

## 36175

THIS FIRST AMENDMENT TO AGREEMENT NO. 36175 is made and entered, in duplicate, as of May, 12, 2022 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meating on November, 9 2021, by and between Blifocus, Inc., a Nevada corporation ("Consultant"), with a place of business at 1930 Village Center Circle, 3-963, Las Vegas, Nevada 89134, and the CITY OF LONG BEACH, a municipal corporation ("Clity").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with the purchase of web-based software to provide the Health Department with a Health Management Information System; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36175 (the "Agreement") whereby Consultant agreed to provide these web-based software services and two hundred three (203) access licenses for its use; and

WHEREAS, City desires to purchase an additional thirty five (35) access licenses and increase the annual rate by $\$ 16,625$ for a total not to exceed amount of \$159,765.

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Partles agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows.
"1.A. Contractor shall furnish specialized services more particularly described in Exhibit " $A$ ", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and Clty shall pay for these seivices in the manner described below, not to exceed One Hundred Forty-Three Thousand One Hundred Forty Dollars ( $\$ 143,140$ ), at the rates or charges shown in Exhibit "B." An additional Sixteen Thousand Six Hundred Twenty-Flve Dollars (\$16,625) is added for a total not to exceed annual amount of One Hundred Fifty-Nine Thousand Seven Hundred Sixty-Flve Thousand Dollars ( $\$ 159,765$ ) and reflected by the rates or charges shown in this
supplemental Exhibit "B-1", altached to this Agreement and Incorporated by this reference."
2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 36175 are ralified and confirmed and shall remain in full force and effect.
