

When was the original Dolly Varden Hotel built? Maybe in the early 1900s?


Of course at that time, Dolly Varden was already 'historical' as a main character in

Long Beach Heritage approves removing and storing the Dolly Varden Hotel sign during the demolition of the historic 1929 building and construction of a new eight-story apartment. We hope that the sign will be kept in a safe place away from the elements and restored in the proper manner, according to the Secretary of the Interior's guidelines. However, we are concerned that the Dolly Varden sign will not be as visible from the street on a new taller building. Placing the sign on the top of an eight-story structure will change the aspect of the view and limit the sign's visibility for passersby. We appreciate that the roof of the new design is set back from the façade, but the sign will only be visible from the south and east to automobile drivers.

Dear Cultural Heritage Commissioners,

We agree with City Staff's recommendations that the Dolly Varden sign be protected, stored, and preserved properly during the demolition of the current 1929 building and the new construction phase at 335 Pacific Avenue.

However, we'd like to point out that on the original three story building there are three views of the historic landmark sign—south, east, and north. We are concerned that the current plans of the new design will block the visibility from the north, diminishing it's historic landmark value. The taller height of the building is already a big change to the view, but with the new white building occupying the now empty parking lot, the sign is being obscured even further.

Although the commission has no say over the building's plans, we respectfully suggest that the white building be reconfigured in stair-stepped fashion—lowered in front and staggered to be taller in back—which would have no loss of square footage or number of units. This reconfiguration would then make the sign on the north side visible to the public as it was originally intended.

Whenever we drive with out-of-town visitors from the north into Downtown, we like to point out the Dolly Varden Hotel sign with its humorous "bath in every room."

We ask that you please direct Staff to have the architects make necessary changes to the current plan to allow for the continuation of the north view of this historic landmark.
