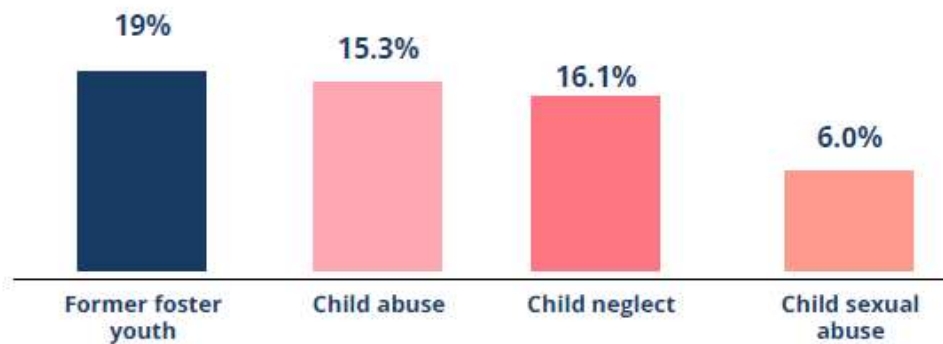
## Childhood Trauma
