4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE AN AGREEMENT WITH QUINN
6 COMPANY TO PURCHASE FOUR CATERPILLAR 430
7 BACKHOE LOADERS, THROUGH CATERPILLAR INC.'S
8 CONTRACT WITH SOURCEWELL IN A TOTAL AMOUNT
9 NOT TO EXCEED \$1,016,512

11 WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802,
12 permits the City to purchase services, supplies, materials, equipment and labor with other
13 government agencies by purchasing under their contracts on a voluntary and selective
14 basis when authorized by resolution; and

15 WHEREAS, the City desires to purchase four Caterpillar 430 backhoe
16 loaders, with related equipment and accessories, for use by the Long Beach Utilities
17 Engineering Bureau for daily operations and special projects; and

18 WHEREAS, Sourcewell is a State of Minnesota local government agency
19 and service cooperative created under the laws of the State of Minnesota (Minnesota
20 Statutes Section 123A.21) that offers cooperative procurement solutions to its members;
21 and

22 WHEREAS, Sourcewell has a contract for the purchase of four Caterpillar
23 430 backhoe loaders, Contract No. 032119-CAT ("Sourcewell Contract"); and

24 WHEREAS, the City's participation in the Sourcewell Contract will facilitate
25 the City's ability to purchase as well as provide considerable cost benefits to the City; and

26 WHEREAS, if the City had to utilize a formal bid process rather than
27 participate in the Sourcewell Contract, considerably more funds would be required;

28 NOW, THEREFORE, the City Council of the City of Long Beach resolves as

2 Section 1. The above recitals are true and correct and are incorporated
3 herein by this reference.

4 Section 2. The City Manager or designee is hereby authorized to enter an
5 agreement with Caterpillar Inc., through its local dealer, Quinn Company, to purchase four
6 Caterpillar 430 backhoe loaders, of the same type and kind identified in the Sourcewell
7 Contract except as modified by mutual agreement of the City and Caterpillar Inc., and the
8 purchase by the City shall be on the same terms and conditions afforded to the Sourcewell
9 in an amount not to exceed One Million Sixteen Thousand Five Hundred Twelve Dollars
10 (\$1,016,512) including tax and shipping.

11 Section 3. This resolution shall take effect immediately upon its adoption
12 by the City Council, and the City Clerk shall certify the vote adopting this resolution.

13 I hereby certify that the foregoing resolution was adopted by the City Council
