23	WHEREAS, City of Long Beach ("Applicant") desires to accept grant funds				
24	from the California Natural Resources Agency for capital improvements at Wrigley				
25	Greenbelt and Multi- Service Center ("Project"); and				
26	WHEREAS, if awarded, Applicant intends to accept an amount up to Five				
27	Million Two Hundred Thousand Dollars (\$5,200,000) for completion of the Project and				
28	authorize the City Manager, or designee, to execute all documents necessary to accept
