Based on the current price increases that we have received from Ford Motor Company during the last two production years, and some as high as a 25% price increase, we are estimating that the manufacturer will continue with new price adjustments in the range of 10% for the 2024 model year.

In working with our fabricators and suppliers, the price of steel has had a tremendous increase and there is still supply chain issues, which not only increase pricing of products but there are many delays in ordering, production and deliveries.
