FIFTH AMENDMENT TO AGREEMENT NO. 34663

THIS FIFTH AMENDMENT TO AGREEMENT NO. 34663 is made and entered, in duplicate, as of June 7, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023, by and between WESTGROUP DESIGNS, INC., a California corporation ("Consultant"), with a place of business at 19520 Jamboree Road, Suite 100, Irvine, CA 92612, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34663 (the "Agreement") whereby Consultant agreed to provide as needed urban planning design services for a period of two (2) years with the option to renew for three (3) additional one-year periods in an amount not to exceed Six Hundred Thousand Dollars (\$600,000); and

WHEREAS, the Parties entered into a First Amendment to increase the contract amount for a total not to exceed Eight Hundred Thousand Dollars (\$800,000), and extend the term of the Agreement to June 30, 2020; and

WHEREAS, the Parties entered into a Second Amendment to increase the contract amount for a total not to exceed Nine Hundred Thousand Dollars (\$900,000), and extend the term to June 30, 2021; and

WHEREAS, the Parties entered into a Third Amendment to extend the term of the Agreement to June 30, 2022; and

WHEREAS, on June 21, 2022, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fourth Amendment to extend the term to June 30, 2023, update the City Representative, and attach an updated rate sheet; and

WHEREAS, on June 6, 2023, City Council approved to extend the term of the Agreement by one (1) additional one-year period; and

WHEREAS, the Parties desire to extend the term of the Agreement using the

authorized one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34663 are ratified and confirmed and shall remain in full force and effect.
