FIFTH AMENDMENT TO AGREEMENT NO. 34656 34656

THIS FIFTH AMENDMENT TO AGREEMENT NO. 34656 is made and entered, in duplicate, as of June 7, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023, by and between KAMUS KELLER, INC., a California corporation ("Consultant"), with a place of business at 1965 Yosemite Avenue #205, Simi Valley, California 93063, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34656 (the "Agreement") whereby Consultant agreed to provide as needed urban planning design services for a period of two (2) years with the option to renew for three (3) additional one-year periods in an amount not to exceed Six Hundred Thousand Dollars (\$600,000); and; and

WHEREAS, the Parties entered into a First Amendment to increase the contract amount for a total not to exceed One Million Six Hundred Thousand Dollars (\$1,600,000), and extend the term to June 30, 2020; and

WHEREAS, the Parties entered into a Second Amendment to extend the term of the Agreement to June 30, 2021; and

WHEREAS, the Parties entered into a Third Amendment to extend the term of the Agreement to June 30, 2022; and

WHEREAS, on June 21, 2022, City Council approved extending the Agreement one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fourth Amendment to extend the term to June 30, 2023, update the City Representative, and attach an updated rate sheet; and

WHEREAS, on June 6, 2023, City Council approved to extend the term of the Agreement by one (1) additional one-year period; and

WHEREAS, the Parties desire to extend the term of the Agreement using the authorized one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34656 are ratified and confirmed and shall remain in full force and effect.
