SECOND AMENDMENT TO AGREEMENT NO. 36038

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 36038 is made and entered, in duplicate, as of May 23, 2023, for reference purposes only, pursuant to a minute 4 order adopted by the City Council of the City of Long Beach at its meeting on May 23, 5 2023, by and between DEWBERRY ENGINEERS INC., a New York corporation 6 ("Consultant"), with a place of business at 8401 Arlington Boulevard, Fairfax, Virginia 22031, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed professional engineering services ("Project"); and 10

11 WHEREAS, on July 6, 2021, the City Council adopted Specifications No. RFQ PW20-059 and awarded agreements for as-needed professional engineering 12 services for a period of two (2) years, with the option to renew for three (3) additional one-13 year periods, at the discretion of the City Manager; and 14

15 WHEREAS, the City and Consultant (the "Parties") entered into Agreement No. 36038 (the "Agreement") whereby Consultant agreed to provide these services; and 16

17 WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement to July 31, 2024, attach an updated rates sheet, and update the City's 18 Representative; and 19

20 WHEREAS, on May 23, 2023, the City Council authorized an increase to the aggregate contract total in an amount not to exceed Ninety Million Dollars (\$90,000,000) 21 for all agreements created under Specification No. RFQ PW20-059; and 22

23 WHEREAS, the Parties desire to increase the authority of this Agreement by Two Hundred Thousand Dollars (\$200,000); 24

25 NOW, THEREFORE, in consideration of the mutual terms, covenants, and 26 conditions herein contained, the Parties agree as follows:

Section 1.A. of the Agreement is hereby amended to read as follows. 1. "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and Incorporated by this reference, in
 accordance with the standards of the profession, and City shall pay for these services in
 the manner described below, in an amount not to exceed Four Million Two Hundred
 Thousand Dollars (\$4,200,000), at the rates or charges shown in Exhibit "B-1" of the First
 Amendment to the Agreement."

Except as expressly modified herein, all of the terms and conditions
contained in Agreement No. 36038 are ratified and confirmed and shall remain in full force
and effect.
