CA 90802-4664 RFQ PW0-059 and awarded agreements for as-needed professional engineering services 12 for a period of two (2) years, with the option to renew for three (3) additional one-year 13 14 periods, at the discretion of the City Manager; and 15 WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36042 (the "Agreement") whereby Consultant agreed to provide these services; and 16 17 WHEREAS, the Parties entered into a First Amendment to extend the term of the Agreement to July 31, 2024, attach an updated rates sheet, and update the City's 18 19 Representative; and 20 WHEREAS, on May 23, 2023, the City Council authorized an increase to the 21 aggregate contract total in an amount not to exceed Ninety Million Dollars (\$90,000,000) 22 for all agreements created under Specification No. RFQ PW20-059; and 23 WHEREAS, the Parties desire to increase the authority of this Agreement by 24 Two Million Dollars (\$2,000,000); 25 NOW, THEREFORE, in consideration of the mutual terms, covenants, and 26 conditions herein contained, the Parties agree as follows: 27 1.
