NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- "F. The term of this Agreement shall commence at midnight on December 15, 2020, and shall terminate at 11:59 p.m. on October 31, 2023."
