SECOND AMENDMENT TO AGREEMENT NO. 36113

THIS SECOND AMENDMENT TO AGREEMENT NO. 36113 is made and entered, in duplicate, as of May 31, 2023 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 7, 2021, by and between CSG CONSULTANTS, INC., a California corporation ("Consultant"), with a place of business at 3707 West garden Grove Boulevard, #100, Orange, California 92868, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspections services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 36113 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to increase the contract amount to \$450,000; and

WHEREAS, the Parties desire to extend the term for one(1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 2. of the Agreement is hereby amended to read as follows.

TERM. The term of this Agreement shall commence at midnight on November 1, 2021, and shall terminate at 11:59 p.m. on October 31, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The term may be extended for two (2) additional one-year periods, at the discretion of the City Manager."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 36113 are ratified and confirmed and shall remain in full force and effect.
