## **TENTH AMENDMENT TO AGREEMENT NO. 33498**

THIS TENTH AMENDMENT TO AGREEMENT NO. 33498 is made and entered, as of July 24, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023, by and between HIRSCH & ASSOCIATES, INC., a California corporation, with a place of business at 2221 East Winston Road, Suite A, Anaheim, California 92806 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33498 (the "Agreement") whereby Consultant agreed to provide as-needed landscape architectural services in a total not to exceed amount of Two Hundred Fifty Thousand Dollars (\$250,000) for a period of two (2) years with the option to extend for three (3) additional one-year periods; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the authority amount for a total not to exceed Seven Hundred Fifty Thousand Dollars (\$750,000); and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to August 1, 2017, and increase the authority amount for a total not to exceed Eight Hundred Fifty Thousand Dollars (\$850,000); and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to increase the authority amount for a total not to exceed One Million Dollars (\$1,000,000); and

WHEREAS, on June 13, 2017, City Council approved extending the term of the Agreement by one (1) additional one-year period; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to extend the term to August 1, 2018, and increase the authority amount for a total not to exceed Two Million Dollars (\$2,000,000); and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to

extend the term to August 1, 2019, and update the City Representative; and

WHEREAS, the Parties entered into a Sixth Amendment to the Agreement to extend the term to August 1, 2020; and

WHEREAS, the Parties entered into a Seventh Amendment to the Agreement to extend the term to August 1, 2021; and

WHEREAS, on July 6, 2021, City Council approved extending the term of the Agreement by one (1) additional one-year period; and

WHEREAS, the Parties entered into an Eighth Amendment to the Agreement to extend the term to August 1, 2022, increase the authority amount for a total not to exceed Three Million Dollars (\$3,000,000), and attach an updated Rate Sheet; and

WHEREAS, on July 5, 2022, City Council approved extending the term of the Agreement by one (1) additional one-year period; and

WHEREAS, the Parties entered into a Ninth Amendment to the Agreement to increase the authority amount for a total not to exceed Four Million Dollars (\$4,000,000), extend the term to August 1, 2023, attach an updated rate sheet, and update the City Representative; and

WHEREAS, on June 6, 2023, City Council approved extending the term of the Agreement by one (1) additional one-year period; and

WHEREAS, the Parties desire to extend the term of the Agreement utilizing the additional one-year term;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. TERM. The term of this Agreement shall commence at midnight on August 1, 2014, and shall terminate at 11:59 p.m. on August 1, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
  - 2. Except as expressly modified herein, all of the terms and conditions

contained in Agreement No. 33498 are ratified and confirmed and shall remain in full force 1 2 and effect.
