# 34362 FIFTH AMENDMENT TO AGREEMENT NO. 34362

THIS FIFTH AMENDMENT TO AGREEMENT NO. 34362 is made and 3 entered, as of July 6, 2023, for reference purposes only, pursuant to a minute order 4 adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023, by 5 and between GRIFFIN STRUCTURES, INC., a California corporation ("Consultant"), with 6 a place of business at 1 Technology Drive, Suite 1829, Irvine, California 92618, and the 7 CITY OF LONG BEACH, a municipal corporation ("City"). 8

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 9 34362 (the "Agreement") under Specification No. RFQ PW16-115, whereby Consultant 10 agreed to provide as-needed public works construction management and inspection 11 services in an amount not to exceed Five Hundred Thousand Dollars (\$500,000) for a 12 period of three (3) years with the option to extend for two (2) additional one-year periods, 13 at the discretion of the City Manager; and 14

WHEREAS, the Parties entered into a First Amendment to the Agreement to 15 extend the term to August 31, 2020; and 16

WHEREAS, the Parties entered into a Second Amendment to the Agreement 17 to extend the term to August 31, 2021; and 18

WHEREAS, on August 3, 2021, the City Council authorized increasing the 19 aggregate not to exceed amount and extended the term to August 31, 2022, for as-needed 20 construction management and inspection services for all public works projects created 21 under Specification No. RFQ PW16-115; and 22

WHEREAS, the Parties entered into a Third Amendment to the Agreement 23 to extend the term to August 31, 2022; and

WHEREAS, on July 19, 2022, the City Council authorized increasing the aggregate not to exceed amount and extended the term to August 31, 2023, for as-needed 26 construction management and inspection services for all public works projects created 27 under Specification No. RFQ PW16-115; and 28

NOW, THEREFORE, in consideration of the mutual terms, covenants, and
 conditions herein contained, the Parties agree as follows:

Section 2 of the Agreement is hereby amended to read as follows:

13 "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on
14 August 31, 2016, and shall terminate at 11:59 p.m. on August 31, 2024, unless sooner
15 terminated as provided in this Agreement, or unless the services or the Project is
16 completed sooner."

17 2. The Rates attached as Exhibit "B-1" in the Fourth Amendment to the
18 Agreement are hereby amended and replaced by Exhibit "B-2", attached hereto and
19 incorporated herein.

203. Except as expressly amended herein, all terms and conditions in21Agreement No. 34362 are ratified and confirmed and shall remain in full force and effect.


