## FIFTH AMENDMENT TO AGREEMENT NO. 34363

THIS FIFTH AMENDMENT TO AGREEMENT NO. 34363 is made and 3 entered, as of July 6, 2023, for reference purposes only, pursuant to a minute order 4 adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023, by 5 6 and between TOTUM CORP, a California corporation ("Consultant"), with a place of business at 15130 Ventura Boulevard, Unit A, Sherman Oaks, California 91403, and the 7 8 CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34363 (the "Agreement") under Specification No. RFQ PW16-115, whereby Consultant agreed to provide as-needed public works construction management and inspection services in a not to exceed amount of One Million Dollars (\$1,000,000) for a period of three (3) years with the option to extend for two (2) additional one-year periods, at the discretion of the City Manager; and

15 WHEREAS, the Parties entered into a First Amendment to the Agreement to 16 extend the term to August 31, 2020; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement 17 18 to extend the term to August 31, 2021; and

19 WHEREAS, on August 3, 2021, the City Council authorized increasing the 20 aggregate not to exceed amount and extended the term to August 31, 2022, for as-needed 21 construction management and inspection services for all public works projects created 22 under Specification No. RFQ PW16-115; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement 23 24 to extend the term to August 31, 2022; and

25 WHEREAS, on July 19, 2022, the City Council authorized increasing the aggregate not to exceed amount and extended the term to August 31, 2023, for as-needed 26 construction management and inspection services for all public works projects created 27 under Specification No. RFQ PW16-115; and 28
