SECOND AMENDMENT TO AGREEMENT NO. 36248

THIS SECOND AMENDMENT TO AGREEMENT NO. 36248 is made and entered, as of August 23, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on June 21, 2022, by and between SO. CAL. SEWER CONSTRUCTION, INC., doing business as SOCAL SEWER & WATER, a California corporation ("Contractor"), with a place of business at 3289 Industry Drive, Signal Hill, California, 90755, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 36248 (the "Agreement") whereby Contractor agreed to provide on-call plumbing maintenance and repair services, and emergency plumbing services in a total annual amount of Five Hundred Nine Thousand Dollars (\$509,000) for a period of two (2) years with the option to extend for three (3) additional one-year periods, at the discretion of the City Manager; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the annual amount by \$116,000 for a total not to exceed annual amount of \$625,000; and

WHEREAS, the Parties desire to utilize their first option to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on October 18, 2021, and shall terminate at 11:59 p.m. on October 17, 2024, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Agreement may be extended for two (2) additional one-year periods, at the discretion of the City Manager."
