FOURTH AMENDMENT TO AGREEMENT NO. 35088

THIS FOURTH AMENDMENT TO AGREEMENT NO. 35088 is made and entered, as of September 7, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 2, 2018, by and between EDCO TRANSPORT SERVICES, LLC, a California limited liability company ("Consultant"), with a place of business at 224 South Las Posas Road, San Marcos, California 92078, and the CITY OF LONG BEACH, a municipal corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 11 35088 (the "Agreement") whereby Consultant agreed to provide municipal residential and 12 commercial solid waste handling services for a period of two (2) years, with the option to 13 renew for three (3) additional one-year periods, in the amount of One Million Five Hundred 14 Twenty-Two Thousand Dollars (\$1,522,000) with a ten percent (10%) contingency in the 15 amount of One Hundred Fifty-Two Thousand Two Hundred Dollars (\$152,200) for a total 16 annual amount not to exceed One Million Six Hundred Seventy-Four Thousand Two 17 Hundred Dollars (\$1,674,200); and

18 WHEREAS, the Parties entered into a First Amendment to the Agreement to
19 extend the term to October 31, 2021, add additional services and attach an updated rate
20 sheet; and

21 WHEREAS, the Parties entered into a Second Amendment to the Agreement 22 to extend the term to October 31, 2022 and attach an updated rate sheet; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to October 31, 2023, and attach an updated rate sheet; and

WHEREAS, on August 15, 2023, City Council authorized to increase the annual authority amount of the Agreement by Five Hundred Forty-Two Thousand Two Hundred Thirteen Dollars (\$542,213) with a ten percent (10%) contingency in the amount of Two Hundred Six Thousand Four Hundred Twenty-One Dollars (\$206,421), and extend

WHEREAS, the Parties desire to increase the annual authority amount by
Five Hundred Forty-Two Thousand Two Hundred Thirteen Dollars (\$542,213), extend the
term using the one (1) one-year term period option, and attach an updated rate sheet;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and
conditions herein contained, the Parties agree as follows:

7 Section 1.A. of the Agreement is hereby amended to read as follows: 1. 8 "A. Consultant shall furnish specialized services more particularly described in Exhibit "A-1", attached to the First Amendment of the Agreement and 9 incorporated by this reference, in accordance with the standards of the profession, and 10 City shall pay for these services in the manner described below, an annual amount of 11 Two Million Sixty-Four Thousand Two Hundred Thirteen Dollars (\$2,064,213), with a ten 12 percent (10%) contingency in the amount of Two Hundred Six Thousand Four Hundred 13 Twenty-One Dollars (\$206,421), for a total not to exceed an annual amount of Two 14 Million Two Hundred Seventy Thousand Six Hundred Thirty-Four Dollars (\$2,270,634), at 15 16 the rates or charges shown in Exhibit "B-4" ,"

2. Section 2 of the Agreement is hereby amended to read as follows:

18 "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on
19 November 1, 2018, and shall terminate at 11:59 p.m. on October 31, 2024, unless sooner
20 terminated as provided in this Agreement, or unless the services or the Project is
21 completed sooner. The Parties have no further options to extend the term."

3. The Rates attached as Exhibit "B-3" to the Third Amendment of the
Agreement are hereby amended in accordance with Exhibit "B-4", attached hereto and
incorporated by this reference.

4. Except as expressly modified herein, all of the terms and conditions
contained in Agreement No. 35088 are ratified and confirmed and shall remain in full force
and effect.


