

SIXTH AMENDMENT TO CONTRACT NO. 35022

THIS SIXTH AMENDMENT TO CONTRACT NO. 35022 is made and entered into on July 24, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on August 3, 2021, by and between PARKWOOD LANDSCAPE MAINTENANCE, INC., a California corporation ("Contractor"), whose address is 16443 Hart Street, Van Nuys, California 91406, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 35022 (the "Contract") whereby Contractor agreed to provide grounds maintenance services in the City of Long Beach; and

WHEREAS, the Parties entered into a First Amendment to the Contract to increase the annual contract amount to \$1,045,973.75 and attach an additional scope of work; and

WHEREAS, the Parties entered into a Second Amendment to the Contract to increase the annual contract amount to \$1,120,873.99 and attach an additional scope of work; and

WHEREAS, the Parties entered into a Third Amendment to the Contract to increase the annual contract amount to \$1,294,770 and attach an additional scope of work; and

WHEREAS, the Parties entered into a Fourth Amendment to the Contract to increase the annual amount to \$1,250,349.18 and attach an additional scope of work; and

WHEREAS, the Parties entered into a Fifth Amendment to the Contract to increase the annual contract amount by \$94,986.25 for an annual total of \$1,345,335.43 for the term of September 1, 2022 to August 31, 2022; to extend the term of the contract from September 1, 2022 to August 31, 2023 for an annual contract amount of \$1,617,471.11, and attach an additional scope of work; and

WHEREAS, the Parties desire enter into a Sixth Amendment to the Contract

1 to extend the term of the contract from September 1, 2023 to August 31, 2026 for an annual  
2 contract amount of \$1,617,471.11.

3 NOW, THEREFORE, in consideration of the mutual terms and conditions  
4 herein contained, the Parties agree as follows:

5 1. Section 2 of the Contract is hereby amended to read as follows:

6 "2. PRICE AND PAYMENT. City shall pay to Contractor the amount(s)  
7 for work and services identified in Contractor's Bid for Ground Maintenance Services in the  
8 City of Long Beach, California, attached to the Contract as Exhibit "A", for the period of  
9 September 1, 2018 to August 31, 2019 an annual amount of One Million Thirty-Eight  
10 Thousand Five Hundred Ninety-Four Dollars (\$1,038,594); for the term of September 1,  
11 2019 to August 31, 2020 an annual amount of One Million Forty-Five Thousand Nine  
12 Hundred Seventy-Three Dollars and Seventy-Five Cents (\$1,045,973.75); for the term of  
13 September 1, 2020 to August 31, 2021 an annual amount of One Million Two Hundred  
14 Ninety-Four Thousand Seven Hundred Seventy Dollars (\$1,294,770); and for the term of  
15 September 1, 2021 to August 31, 2022, an annual amount of One Million Three Hundred  
16 Forty-Five Thousand Three Hundred Thirty-Five Dollars and Forty-Three Cents  
17 (\$1,345,335.43); and for the term of September 1, 2022 to August 31, 2023, an annual  
18 amount of One Million Six Hundred Seventeen Thousand Four Hundred Seventy-One  
19 Dollars and Eleven Cents (\$1,617,471.11); and for the term of September 1, 2023 to  
20 August 31, 2026, an annual amount of One Million Six Hundred Seventeen Thousand Four  
21 Hundred Seventy-One Dollars and Eleven Cents (\$1,617,471.11)."

22 2. Section 4 of the Contract is hereby amended to read as follows:

23 "4. TIME FOR CONTRACT. The term of this Contract shall commence  
24 at midnight on September 1, 2018, and shall terminate at 11:59 p.m. on August 31,  
25 2026, unless sooner terminated as provided in the Contract Documents. The parties  
26 have the option to extend the term for two (2) one-year extension options, for a total  
27 aggregate contract term not to exceed ten (10) years, at the discretion of the City  
28 Manager."
