

1 FIRST AMENDMENT TO PERMIT NO. 29794

3 THIS FIRST AMENDMENT TO PERMIT NO. 29794 is made and entered,  
4 in duplicate, as of January 11, 2008, for reference purposes only, pursuant to a minute  
5 order adopted by the City Council of the City of Long Beach at its meeting on September  
6 6, 2005, by and between THE CITY OF LONG BEACH, a Municipal corporation  
7 ("Lessor") and DADSON WASHER SERVICE, INC. ("Permittee"), a California  
8 corporation.

9 WHEREAS, Lessor granted Permittee exclusive permission to install,  
10 maintain and operate coin-operated washers and dryers for clothing at various locations  
11 in the City of Long Beach;

12 WHEREAS, the parties desire to amend this permit by extending the term;  
13 and

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
15 Permit No. 29794, the parties agree as follows:

16 1. Section 2 of Permit No. 29794 is hereby amended in its entirety to read  
17 as follows:

18 "2. Term. The term of this Permit shall commence at 12:01 a.m.  
19 on September 1, 2008 and shall terminate at midnight on August 31,  
20 2010, unless revoked prior to said expiration date as provided in said  
21 Permit."

22 2. Except as expressly stated herein, all of the terms, covenants, and  
23 conditions of Permit No. 29794 are ratified and confirmed and shall remain in full force  
24 and effect.
