## FIRST AMENDMENT TO AGREEMENT NO. 32374

THIS FIRST AMENDMENT TO AGREEMENT NO. 32374 is made and entered, in duplicate, as of November 20, 2013 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on & July 5. 2011, between **GILLIS** PANICHAPAN ARCHITECTS, by and INCORPORATED, a California corporation, with a place of business at 2900 Bristol Street, Suite G-205, Costa Mesa, California 92626 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with space planning consulting services; and

WHEREAS, the parties entered Agreement No. 32374 whereby Consultant agreed to provide these services; and

WHEREAS, the parties desire to decrease the Agreement amount by \$50,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section 1.A. of Agreement No. 32374 is hereby amended to read as follows:

## "1. SCOPE OF WORK OR SERVICES.

- A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Fifty Thousand Dollars (\$50,000), at the rates or charges shown in Exhibit "B"."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 32374 are ratified and confirmed and shall remain in full force and effect.
