3	THIS FOURTH AMENDMENT TO AGREEMENT NO. 28164 is made and
4	entered, in duplicate, as of September 26, 2006 for reference purposes only, pursuant to
5	a minute order adopted by the City Council of the City of Long Beach at its meeting on
6	October 3, 2006, by and between the LONG BEACH AREA CONVENTION AND
7	VISITORS BUREAU, INC., a California nonprofit corporation ("CVB"), and the CITY OF
8	LONG BEACH, a municipal corporation ("City").
9	WHEREAS, the parties entered Agreement No. 28164 whereby CVB agreed
10	to promote tourism and conventions in the City; and
11	WHEREAS, the parties desire to amend said Agreement to reflect the
12	amount appropriated by the City Council in Fiscal Year 2006-07 from the Special Fund for
13	such promotion, to reflect that the City will participate in the 2007 Rose Parade, and to
14	extend the term of the Agreement;
15	NOW, THEREFORE, in consideration of the mutual terms and conditions
16	contained in Agreement No. 28164 and herein, the parties agree as follows:
17	1. Section 5 of Agreement No. 28164 is hereby amended in its entirety to

18 read as follows:

"5. City's Convention and Tourism Budget. City's City Council has 19 appropriated and allocated from its Special Fund for City convention and tourism sales and 20 development \$3,729,000 for the fiscal year ending September 30, 2004; \$3,930,366 for 21 the fiscal year ending September 30, 2005; \$3,930,366 for the fiscal year ending 22 September 30, 2006; and \$3,930,366 for the fiscal year ending September 30, 2007. 23 City's liability for CVB's approved convention and tourism sales and development programs 24 shall not exceed those amounts. Those amounts include the sums identified in Section 25 17 and 18 hereof and are not additional thereto. City reserves the right, at any time during 26 the term hereof, by notice from City's City Manager, to redefine the scope of services within 27 said amounts. By August 1 of each fiscal year during the term hereof, City's City Manager 28

by the City Council from the City's Special Fund for convention and tourism sales and
development programs for the following fiscal year. No later than June 1 of each fiscal
year during the term hereof, CVB shall prepare and submit the marketing plan referred to
in Section 2(a) hereof based on the anticipated transient occupancy taxes to be
appropriated."

7 2. All references in Section 18 of Agreement No. 28164 to the 2003
8 Tournament of Roses Parade shall hereafter mean and refer to the 2007 Tournament of
9 Roses Parade.

3. Except as expressly modified herein, all of the terms and conditions
 contained in Agreement No. 28164 are ratified and confirmed and shall remain in full force
 and effect.


