FIRST AMENDMENT TO AGREEMENT NO. 33843

THIS FIRST AMENDMENT TO AGREEMENT NO. 33843 is made and entered, in duplicate, as of August 25, 2015 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 7, 2015, by and between KOA CORPORATION, a California corporation ("Consultant"), with a place of business at 2141 West Orangewood Avenue, Suite A, Orange, California 92868, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with as-needed traffic engineering, transportation planning and related technical and professional services; and

WHEREAS, the parties entered Agreement No. 33843 whereby Consultant agreed to provide these services; and

WHEREAS, the parties desire to increase the Agreement amount by \$200,000 for a total not to exceed amount of \$800,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

- 1. Section 1.A. of Agreement No. 33843 is hereby amended to read as follows:
 - "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Eight Hundred Thousand Dollars (\$800,000), at the rates or charges shown in Exhibit "B".
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33843 are ratified and confirmed and shall remain in full force and effect.
