	Provide all labor, materials and equipment for additional palm tree including stump removal and contractors proposed Change Order No. 41, as directed by the Project Manager,	
	for the lump sum cost of	2,110.90

Provide all labor, materials and equipment to place a concrete cut off wall to decrease the flow of water exiting the low flow pump station allowing for the pumps to keep up with demand and contractors proposed Change Order No. 42, as directed by the Project Manager,

Provide all labor, materials and equipment for changes in the new pump house configuration, resulted in additional concrete, which reinforcement bars, excavation, intake box as directed by the County of Los Angeles plan check, and contractors proposed Change Order No. 43, as directed by the Project Manager,
