Subject: Interest Form for Argument Writers Submissions

Pursuant to Long Beach Municipal Code 1.24.020, the Mayor, with the approval of the City Council, may designate a person, or association of persons, to write arguments either for or against or both for and against the adoption of any measure placed on the ballot. In making such designation, the Mayor must designate one (1) of the following:

- A. The Mayor;
- B. An elected officer of the City;
- C. An appointive officer of the City;
- D. An association of citizens; or
- E. An individual voter.

Pursuant to California State Elections Code 9283, no more than five signatures shall appear with any argument submitted.

On March 3, 2016, the Office of the City Clerk issued a public notice calling for argument writers for the two ballot measures appearing on the June 7, 2016 California Statewide Primary Election ballot.
