## FIRST AMENDMENT TO AGREEMENT NO. 33857

THIS FIRST AMENDMENT TO AGREEMENT NO. 33857 is made and entered, in duplicate, as of April 13, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 7, 2015, by and between OMNI-MEANS, LTD., a Nevada corporation ("Consultant"), with a place of business at 669 Pacific Street, Suite A, San Luis Obispo, California 93401, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with as-needed traffic engineering, transportation planning and related technical and professional services; and

WHEREAS, the parties entered Agreement No. 33857 whereby Consultant agreed to provide these Services; and

WHEREAS, the parties desire to decrease the agreement amount by \$150,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 1.A of Agreement No. 33857 is hereby amended to read as follows:

## "1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Fifty Thousand Dollars (\$250,000), at the rates or charges shown in Exhibit "B"."

 Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33857 are ratified and confirmed and shall remain in full force and effect.
