### BACKGROUND

I (Officer J Flores #10007) am a Police Officer in the City of Long Beach assigned to the West Division as a Patrol Resource Officer. I am specifically tasked with impacting Community Oriented Public Safety "COPS" locations.

COPS locations are typically long-term problem locations, which may require other city resources in order to eradicate long-term problems.

Miko's bar, which is located at 710 W. Willow Street, has been identified as a possible problem location by the local residents in the area, specifically several who reside on the 2500 block of Main Ave. Under the Long Beach Police Department's COPS philosophy, this location is a COPS location. For further see COPS DR #15-62480.

#### CALL# L152621315

The call stated there was a group of 8 subjects in several different vehicles. The call went on to state the subjects were keeping alcohol in a possibly gray vehicle. The call further stated there was a male unknown wearing a yellow hat who was possibly supplying the liquor.

#### **DISPATCH**

On 10/21/15 at approximately 1620 hours, I responded to a community group meeting at 2569 Maine Avenue to discuss the community group's concerns regarding Miko's bar. At that time I contacted the Victim, who was identified by her California Identification Card as Antoinette Kadrmas, who advised me she was the calling party of Call #L152621315 and went on to tell me the following:

Kadrmas had video regarding the incident and desired prosecution.

During my investigation I was advised by the homeowner, who was identified as Ricky Oropeza, of that the community group had purchased surveillance system and had mounted the cameras on his property.

Due to the nuisance activity occurring rear of Miko's bar, the surveillance cameras covered the parking lot of Miko's bar as well as much of the northwest corner of Orepeza's front yard. The members of the community group concerned with the nuisance activity of the bar were given Internet access to the surveillance cameras.

Both Oropeza and Kadrmas began to show me surveillance video from Call #L152621315, which had been recorded onto the DVR.

### Narrative

Video time stamped 09-19-2015 1835: I observed 6 male Black subjects who were loitering in the alley and the parking lot rear of Miko's bar. One of the male Black subjects who had been described in the call appeared to be taking an unknown bottle of what appeared to be an alcoholic beverage out from the backseat of a blue sedan and fill subject's cups with the substance.

While I observed the video I observed the subjects who were loitering and drinking an unknown beverage in the alley and parking lot walk in to the back door of the Miko's bar, entering the bar after they finished their unknown beverage.

I also observed an unknown male Black subject open a bottle of an alcoholic beverage, drink from it, outside of the back door of Miko's bar, and walk in through the back door. Moments later I went on to observe the same subject walk out of the back door of Miko's bar, return to where he had left the bottle, and continue to drink from it.

#### KADRMAS STATEMENT:

A Brown

I asked Kadrmas how she knew to start looking at her surveillance video when the subjects were drinking. Kadrmas went on to tell me her peace had been disturbed because of the loud talking coming from the rear of Miko's bar. Kadrmas then began to view the subjects through the surveillance video.

Kadrmas believed Miko's bar was the direct cause of subjects loitering rear of the bar and drinking in public and the loud noise which disturbed her peace. Kadrmas advised me she desired prosecution for witnessing, what she believed to be, drinking in public of an alcoholic beverage and her peace being disturbed from the loud talking. Kadrmas signed a Private Person's Arrest Report "PPA". I provided a report receipt to Kadrmas.

#### **EVIDENCE:**

Due to the lack of knowledge of the DVR system, Oropeza or Kadrmas were unable to provide me with a copy of the surveillance video.

On 11/03/15 I returned to where Oropeza was able to provide me a copy of the surveillance video. I uploaded the video to Mideo prior to placing the copy of the video into evidence.
