WHEREAS, the Parties desire to increase the annual Contract amount by Two Million Dollars (\$2,000,000) for a revised annual amount not to exceed Four Million Five Hundred Thousand Dollars (\$4,500,000);

NOW, THEREFORE, in consideration of the mutual terms and conditions herein contained, the Parties agree as follows:

- 1. Section 2.A. of the Contract is hereby amended to read as follows:
- "A. City shall pay to Contractor the amount(s) for materials and work identified in Contractor's Bid for the Annual Contract for Plastic Gas Pipeline Construction in the City of Long Beach, California, attached hereto as Exhibit "A"; provided, however, that the total compensation to Contractor shall not exceed an annual amount of Four Million Five Hundred Thousand Dollars (\$4,500,000) during the term of this Contract."
