#### **RECOMMENDATION:**

Adopt the recommendation of the Homeless Services Advisory Committee to allocate funding in the amount of \$15,000 from the Mayor's Fund for the Homeless to Urban Community Outreach;

Authorize the City Manager, or designee, to execute all necessary documents with Urban Community Outreach, for the provision of services for people experiencing homelessness; and,

Increase appropriations in the General Fund (GF) in the Health and Human Services Department (HE) by \$15,000. (Citywide)

#### **DISCUSSION:**

On September 14, 1990, the City Council approved an Ordinance establishing the Mayor's Fund for the Homeless (Mayor's Fund). Since January of 1992, a solicitation envelope for the Mayor's Fund has been included in the City's utility bill each year and the Mayor's Fund receives an average of \$25,000 in contributions annually. The available balance of the Mayor's Fund as of December 12, 2017 was \$129,208.

On November 1, 2017, the Homeless Services Advisory Committee (HSAC) held a meeting to discuss a special allocation of the Mayor's Fund (Exhibit A – HSAC meeting minutes). HSAC recommends that a portion of the Mayor's Fund, in the amount of \$15,000 be allocated to Urban Community Outreach for the provision of homeless services, with the balance to remain in the Mayor's Fund to accrue interest. Urban Community Outreach will provide relocation assistance for homeless individuals or families seeking to be reconnected with their home town social support networks as well as provide short-term motel voucher assistance in the absence of shelter availability. The total fund allocation will be used exclusively for transportation costs related to relocation assistance and motel voucher expenditures.

This matter was reviewed by Deputy City Attorney Linda T. Vu on December 18, 2017 and by Revenue Management Officer Geraldine Alejo on December 27, 2017.

# **TIMING CONSIDERATIONS**

City Council action is requested on January 16, 2018, so the Department of Health and Human Services, Homeless Services Division may provide payment to Urban Community Outreach in a timely manner.

# **FISCAL IMPACT**

Funds are allocated from donations to the Mayor's Fund Expendable Trust (EX 440). An increase in appropriations in the amount of \$15,000 in the General Fund (GF) in the Health and Human Services Department (HE) is requested. Appropriations are fully offset by revenue from the Expendable Trust. There is no local job impact associated with this recommendation.

HSAC Revised Request Attention: Homeless Services Officer, Shannon Parker Mayor's Fund

Dear Shannon and HSAC Friends,

When I attended the October 4, 2017 HSAC Meeting I was asked to modify the Urban Community Outreach request for your support of up to \$15,000 this year. I was asked to omit the portion of the request to be used for prevention, such as rental assistance and come back next month. Though I feel it is also an emergency when you are about to be evicted and thrown into the street, I have revised it. We would be appreciative of support in the areas you feel are in focus with the Mayor's Fund. Please see my revised request below.

We are helping so many families with motel vouchers while they work with us on their goals. We also help people go "home" to other locations. When they find it just too hard to survive in Long Beach we pay their greyhound transportation costs. Other transportation is given to people who have local interviews for work, doctor appointments, and educational classes they need to go to so they can change their lives. Your gift will help us with all these costs that are draining us. This contribution would make it possible to better serve the community of less fortunate people and keep more people from living in the streets of Long Beach. It will help many families and individuals rise out of poverty into stability in a happy more self-sufficient life in permanent housing with services.

UCO is working with MSC and CoC to verify services, homelessness, and to leverage funding with our community partners.

We are making sure we help navigate people through the system, not duplicating services. My 3 case managers and I will maximize this funding to serve those experiencing homelessness. We fill a gap in services as we are open on Sundays.

To name some of the things we did in 2016- we prevented eviction 14 times with rental assistance, provided 607 motel bed nights, were able to serve 20,000 hot meals to 2,798 unduplicated individuals. We've found free pre-school for 4 families, helped 4 families into a permanent apartment and gave 6 families furniture and new household items for their kitchen and bedrooms! We are so proud to change their lives for the better and point them in the right direction! We can't do it alone!

We have many individuals and families, including a large percent of single parent families, coming to us for help. Households with a woman as the head of the household find it particularly hard to get by. Many seniors also need the help because of being on a fixed income and housing so high. We provide all with warm nourishing meals, resources and referrals and





help them to compete in the job market with computer and food service skills, give them access to a computer lab, teach resume building, store their documents, provide healthcare, mental health and addiction care, childcare assistance, provide temporary shelter, and permanent housing assistance and services once in housing.
