3	THIS SECOND AMENDMENT TO AGREEMENT NO. 33838 is made and
4	entered, in duplicate, as of March 8, 2018, for reference purposes only, pursuant to a
5	minute order adopted by the City Council of the City of Long Beach at its meeting on April
6	7, 2015, by and between ALBERT GROVER & ASSOCIATES, INC., a California
7	corporation ("Consultant"), with a place of business at 211 East Imperial Highway, Suite
8	208, Fullerton, California 92835, and the CITY OF LONG BEACH, a municipal corporation
9	("City").
10	WHEREAS, City requires specialized services requiring unique skills to be
11	performed in connection with as-needed traffic engineering, transportation planning and
12	related technical and professional services; and
13	WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
14	33838 (the "Agreement") whereby Consultant agreed to provide these services; and
15	WHEREAS, the Parties entered into a First Amendment to the Agreement to
16	increase the amount by \$150,000 for a total not to exceed amount of \$750,000; and
17	WHEREAS, the Parties desire to increase the amount by \$100,000 for a total
18	not to exceed amount of \$850,000 and extend the term one (1) additional one-year period;
19	NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20	conditions herein contained, the Parties agree as follows:
21	1. Section 1.A of the Agreement is hereby amended to read as follows:
22	"1. <u>SCOPE OF WORK OR SERVICES</u> .
23	A. Consultant shall furnish specialized services more particularly
24	described in Exhibit "A", attached to this Agreement and incorporated by this reference, in
25	accordance with the standards of the profession, and City shall pay for these services in
26	the manner described below, not to exceed Eight Hundred Fifty Thousand Dollars
27	(\$850,000), at the rates or charges shown in Exhibit "B"."
28	2. Section 2 of the Agreement is hereby amended to read as follows:

"2. <u>TERM</u>. The term of this Agreement shall commence at midnight on
June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2019, unless sooner terminated
as provided in this Agreement, or unless the services or the Project is completed sooner.
The Parties have the option to extend the term one (1) additional one-year period."

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33838 are ratified and confirmed and shall remain in full force and effect.
