

8	The City Council of the City of Long Beach ordains as follows:

10	Section 1. Table 39-1 of Section 21.39.230 of the Long Beach Municipal	
11	Code is amended to read as follows:	
12	Table 39-1	
13	High-Rise Yard Requirements	
14		
15	Yard	Required Setback
16	1. Yards abutting a street <sup>(a)</sup>	20 ft.
17	2. Yards abutting residential district <sup>(b)</sup>	
18	a. If building height less than or equal to 45 ft.	Same as underlying district
19	b. If building height greater than 45 ft.	1/5 of the building height, but total setback not to exceed fifteen (15) percent of the lot width or depth as applicable
20	3. Yards abutting	
21	nonresidential district	Same as underlying district
22		
23	(a) An average setback for yards abutting a street shall be allowed through the Site Plan Review process, provided no building encroaches more than ten feet (10') into the required setback. For purposes of establishing an average setback, no portion of a building setback more than thirty feet (30') may contribute to the average setback

26	(b) Includes residential district across an alley.
