

THIRD AMENDMENT TO CONTRACT NO. 34289

THIS THIRD AMENDMENT TO CONTRACT NO. 34289 is made and entered, in duplicate, as of June 7, 2018, for reference purposes only, pursuant to minute order adopted by the City Council of the City of Long Beach at its meeting on March 22, 2016, by and between THE MICHELSON FOUND ANIMALS FOUNDATION, INC. ("FOUND ANIMALS"), a California corporation with a place of business at P.O. Box 66370, Los Angeles, CA 90066, STRAY CAT ALLIANCE ("SCA"), a California corporation with a place of business at P.O. Box 41021, Los Angeles, CA 90041, and the CITY OF LONG BEACH, LONG BEACH ANIMAL CARE SERVICES ("LBACS"), a municipal corporation.

WHEREAS, FOUND ANIMALS, SCA and LBACS (the "Parties") entered into Contract No. 34289 ("Contract") whereby City agreed to provide a variety of services to decrease shelter euthanasia of cats; and

WHEREAS, the Parties wish to revise the Contract to include rabies vaccinations to the program tasks; and

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the Parties agree as follows:

1. Section III. of Contract No. 34289 is hereby amended to read as follows:

"III. PROGRAM TASKS

The Parties agree to the following tasks:

- **FOUND ANIMALS** will appoint a representative with appropriate knowledge and decision-making authority to attend monthly program update meetings. In addition, FOUND ANIMALS will:

- o Fund SCA for up to 800 cats obtained from LBACS in calendar year 2016. In future years, if any, FOUND ANIMALS will review the prior year successes to determine the level of funding.

1 • SCA will appoint a representative(s) with appropriate knowledge and

- 5 ○ Utilize best efforts to release 800 cats (greater than three months of
- 6 age) impounded by LBACS.
- 7 ○ Pay the LBACS to spay/neuter and provide rabies vaccinations at

11 contained in Contract No. 34289 are ratified and confirmed and shall remain in full force
