## THIRD AMENDMENT TO AGREEMENT NO. 33840

THIS THIRD AMENDMENT TO AGREEMENT NO. 33840 is made and entered, in duplicate, as of January 31, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 7, 2015, by and between LG2WB ENGINEERS, INC. DBA LINSCOTT, LAW & GREENSPAN ENGINEERS, a California corporation ("Consultant"), with a place of business at 2 Executive Circle, Suite 250, Irvine, California 92614, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed traffic engineering, transportation planning and related technical and professional services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33840 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to decrease the amount by \$100,000 for a total not to exceed amount of \$300,000; and

WHEREAS, the Parties entered into a Second Amendment to extend the term to May 31, 2019; and

WHEREAS, the Parties desire to extend the term one (1) additional oneyear period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on June 1, 2015, and shall terminate at 11:59 p.m. on May 31, 2020, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
  - 2. Except as expressly modified herein, all of the terms and conditions
