City Council action is requested on May 14, 2019, to respond to the Department of Alcoholic Beverage Control by the May 15, 2019 due date.



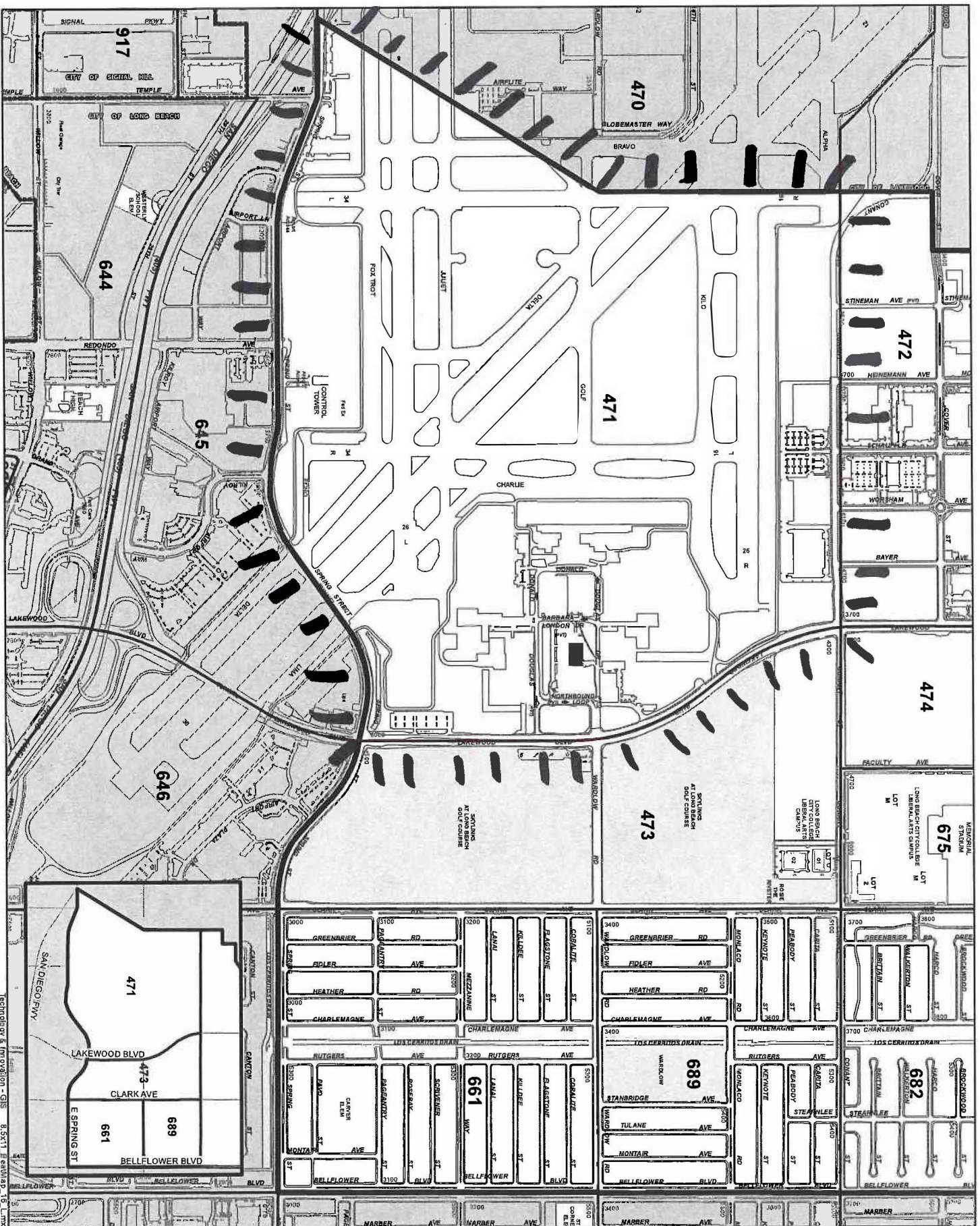
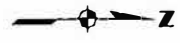
